MyNAGS Terms & Conditions of Use

- 1. In this MyNAGS Terms & Conditions of Use, unless the subject matter determines otherwise:
 - (i) NAGS or National Auto Glass Supplies or our or us or we means:
 - a. "National Auto Glass Supplies Australasia Pty Ltd" (ABN 36 662 932 747) and its executors, administrators, successors and permitted assigns in the Australia market; and
 - b. NAGS (New Zealand) Limited (Company No. 1795419 / GST No. 127-527-475) and its executors, administrators, successors and permitted assigns in the New Zealand market;
 - (ii) **Customer** or **you** or **your** means the person or entity who purchases Goods from NAGS regardless of whether the person or entity has completed any account application form with NAGS and includes the Customer and Customer's employees, authorised person and user who have access to NAGS' online ordering portal;
 - (iii) **NAGS' online ordering portal** or **MyNAGS** mean the order platform/portal/app/software/website and any other digital and online method or format that NAGS allows the Customer access to make purchase or do product search from NAGS;
 - (iv) The singular includes the plural and vice versa and any gender includes any other gender;
 - (v) An expression importing a natural person includes a body corporate, partnership, joint venture, association or other legal entity; and
 - (vi) A reference to a statute, statutory provision or regulation includes all amendments, consolidations or replacements thereof.
- MyNAGS is an online portal designed and provided by NAGS for the benefit of approved NAGS customers allowing NAGS' customers to view, order, check product information and access account details. The number of features and/or functionalities available under MyNAGS is under the absolute control of NAGS and may be reviewed or changed from time to time in NAGS' absolute discretion.
